

IFLA의 서지레코드 기능요건(FRBR) 모형 고찰

A Study on IFLA Functional Requirements for Bibliographic Records Model

초 록

목록의 기능은 크게 두 가지로 대별되는데, 하나는 집서 중의 특정 문헌을 식별하여 검색하는 기능이고 다른 하나는 특정 저자의 모든 저작과 특정 저작과 관련된 자료를 목록 상에서 한자리에 집중하는 기능이다. 본 논문에서는 목록의 기능을 재검토하고, 목록의 기능을 효과적으로 수행하기 위한 참조 개념 모형(conceptual model)으로서 IFLA에서 제안한 서지레코드의 기능요건(Functional Requirements for Bibliographic Records, FRBR) 모형에 대해서 검토하였다.

ABSTRACTS

Catalog serves a dual purposes. One is finding function(or identifying function) that is identified and located specific items and the other is collocating function which is displayed specific author's all works and all related editions.

This study is re-examined the functions of catalog. For catalog's effective serving this study is provided and overviewed the FRBR(Functional Requirements for Bibliographic Record) models as reference conceptual model for functions of catalog.
